EXECUTIVE SUMMARY

For the month of September, the FBMKLCI Index closed lower by 1.9% MoM to 1,424.17 points. This has widened the YTD loss to -4.8%. Investors were cautious due to global inflation concerns, fueled by elevated crude oil prices and the looming the US government shutdown. The average daily trading value in the month rose 11.6% MoM and 24.7% YoY to RM2.2bil. Meanwhile, average daily trading volume in rose 11.8% MoM and 43.3% YoY to 3.5bil units.

Malaysia Government Securities ("MGS") yields spiked higher across the curve, in line with the increasing global bond yields. Brent crude oil prices jumped to USD95.31/barrel as at end-Sep'23 (end-Aug: USD86.86/barrel), driven by the rising global demand and OPEC+ production cuts. Meanwhile, ringgit continued to weaken against the dollar to RM4.6950/USD (end-Aug'32: RM4.6385/USD).

On the local economic data, inflation was seen unchanged at +2.0% YoY in Aug'23. Malaysia's exports and imports declined further by -18.6% YoY and -21.2% YoY respectively in Aug'23.

For the equity market, after series of interest rate hikes by the US Federal Reserve to fight against inflation in the 1H2023, the economy has proven to be more resilient than anticipated. We are more optimistic about the outlook for economic expansion this year. Locally, post OPR rate hike to 3.00% in May 2023, we expect BNM to maintain the OPR unchanged for the remaining of 2023. The OPR rate hike will be negatively impact to the local equity market for short term period. However, for longer term, we expect there will be recovery in the 2H2023 when the inflation started to inch lower. Historical analysis is suggesting that lower interest rates due to lower inflation will be positive for the equity market.

Meanwhile for fixed income, after a series of recent OPR hikes to pre-pandemic level, BNM is anticipated to keep its monetary policy unchanged in 2H2023, aiming to balance the economic growth and inflationary pressure in the country. The external risk factors such as Russia-Ukraine geopolitical tension and the fluctuation in crude oil prices will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, our fixed income strategy will remain defensive to shelter from the market volatilities in the near term.

Based on the table below, on a monthly basis, most of the funds managed to outperformed the respective benchmarks, except for Global Yakin Fund.

Investment Objective











Investment Objective

Investment Strategy



Equity Market Review and Outlook

Market Review

For the month of September, the FBMKLCI Index closed lower by 1.9% MoM to 1.424.17 points. This has widened the YTD loss to -4.8%. Investors were cautious due to global inflation concerns, fueled by elevated crude oil prices and the looming the US government shutdown. The average daily trading value in the month rose 11.6% MoM and 24.7% YoY to RM2.2bil. Meanwhile, average daily trading volume in rose 11.8% MoM and 43.3% YoY to 3.5bil units.

Foreign investors stayed net buyers in September for the third month in a row after previously net selling for ten consecutive months. Local institutional investors turned net sellers during September with a net sell flow of RM 545.1mil compared to a net buy flow of RM 432.1mil in August. Local retail investors saw net sell flow decline 78% MoM to RM 95.1mil in September compared to a net sell flow of RM 431.7mil in August.

Meanwhile, global equity markets declined further in September. Investors were bracing for the impact of 'higher for longer' theme as the Federal Reserve signaling that interest rates will likely to stay higher for longer time. DJIA Index closed lower by 3.5% MoM and the broader S&P 500 index closed lower by 4.9% MoM. Eurozone shares also posted loss as the European central bank also maintained their hawkish rhetoric and weak economic data which coming out of Germany. Bloomberg European 500 index closed -2.1% MoM. In Asia, the performances were negative as concerns over the Chinese economy and fears over global economic growth weakened investor sentiment. MSCI Asia APEX 50 ex-Japan closed -3.9% MoM during the month.

Market Outlook & Strategy

Traditionally, FBMKLCI Index's performance tends to be positive in October, with average 1.2%/0.6% MoM returns over the past 10 years/45 years. We expect the market to be supportive by its attractive valuations at current levels of 1.27x as it is now below its 13-year historical average of P/B (1.90x) and 15.5x PER compared to the 13-year historical average of PER (17.2x).

Technically, the FBMKLCI Index bullish MACD crossover happened in July failed to sustain and pulling back the index in September, closed at 1,424 level. This bearish momentum has created a strong resistance at 1,452 level. the Head and Shoulders bearish reversal pattern. Staying below this level indicates bearish momentum and might test psychological level of 1,400. We expect the correction will continue in the near term until there is bullish reversal pattern near the support level. After the psychological level, next support level is marked at 1,317 level, while next support level is seen at 1,500 level.

After series of interest rate hikes by the US Federal Reserve to fight against inflation in the 1H2023, the economy has proven to be more resilient than anticipated. We are more optimistic about the outlook for economic expansion this year. Locally, post OPR rate hike to 3.00% in May 2023, we expect BNM to maintain the OPR unchanged for the remaining of 2023. The OPR rate hike will be negatively impact to the local equity market for short term period. However, for longer term, we expect there will be recovery in the 2H2023 when the inflation started to inch lower. Historical analysis is suggesting that lower interest rates due to lower inflation will be positive for the equity market.

Fixed Income Review and Outlook

Market Review

Malaysia Government Securities ("MGS") yields spiked higher across the curve, in line with the increasing global bond yields. Brent crude oil prices jumped to USD95.31/barrel as at end-Sep'23 (end-Aug: USD86.86/barrel), driven by the rising global demand and OPEC+ production cuts. Meanwhile, ringgit continued to weaken against the dollar to RM4.6950/USD (end-Aug'32: RM4.6385/USD).


On the local economic data, inflation was seen unchanged at +2.0% YoY in Aug'23 (Jul'23: +2.0% YoY). Food and Non-Alcoholic Beverages (FNAB) prices continued to moderate to +4.1% YoY (Jul'23: +4.4% YoY), in line with the easing of global food price inflation. Transport inflation was muted, mainly supported by the Government subsidies on the RON95 and diesel fuel. Malaysia Exports and Imports declined further by -18.6% YoY and -21.2% YoY respectively in Aug'23 (Jul'23:-13.0% and -16.1% YoY respectively). All major Exports segments declined in Aug'23, including Manufacturing, Agriculture and Mining. Contraction in Imports was driven mainly by Re-Exports, Intermediate Goods and Consumption Goods while Capital Goods saw a rebound. In summary, trade surplus remained largely unchanged at +RM17.3b in Aug'23 (Jul'23: +RM17.1b).


BNM's international reserve declined to USD110.1b as at end-Sep'23 (end-Aug'23: USD111.5b). The reserve is sufficient to finance 5.1 months of retained imports and is 1.0 times of short-term external debts.

US 10-year Treasury yield spiked up to 4.67% before easing back to 4.57% as at end-Sep'23 (end-Aug'23: 4.34%), taking cue from the worries of US Government shutdown.

Market Outlook & Strategy

After a series of recent OPR hikes to pre-pandemic level, BNM is anticipated to keep its monetary policy unchanged in 2H2023, aiming to balance the economic growth and inflationary pressure in the country. The external risk factors such as Russia-Ukraine geopolitical tension will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, our fixed income strategy will remain defensive to shelter from the market volatilities in the near term.
