EXECUTIVE SUMMARY

For the month of October 2023, the FBMKLCI Index closed higher by 1.3% MoM to 1,442.14 points, supported by the outperformance in banking sector. This has reduced the YTD loss to -3.6% from -4.77% in a month earlier. The average daily trading value in the month fell 12.3% MoM but rose 15.6% YoY to RM2.0bil. Meanwhile, average daily trading volume in fell 8.9% MoM but rose 15.7% YoY to 3.1bil units.

Malaysia Government Securities ("MGS") yield continued to move higher, in line with the increasing global bond yields. Brend crude oil prices tumbled to USD87.41/barrel as at end-Oct'23 (end-Sep'23: USD95.31/barrel), due to the slower demand worries. Meanwhile, ringgit weakened further against the dollar to RM4.7635/USD (end-Sep'23: RM4.6950/USD), reflecting the heightened geopolitical tension in the Middle East.

On the local economic data, inflation was seen on its easing trend, lowering to +1.9% YoY in Sep'23 (Aug'23: +2.0% YoY).

For the equity market, after series of interest rate hikes by the US Federal Reserve to fight against inflation in the 1H2023, the economy has proven to be more resilient than anticipated. We are more optimistic about the outlook for economic expansion this year. Locally, post OPR rate hike to 3.00% in May 2023, we expect BNM to maintain the OPR unchanged for the remaining of 2023. The OPR rate hike will be negatively impact to the local equity market for short term period. However, for longer term, we expect there will be recovery in the 2H2023 when the inflation started to inch lower. Historical analysis is suggesting that lower interest rates due to lower inflation will be positive for the equity market.

Meanwhile for fixed income, after series of recent OPR hikes to pre-pandemic level, BNM is anticipated to keep its monetary policy unchanged in 2H2023, aiming to balance the economic growth and inflationary pressure in the country. The external risk factors such as Russia-Ukraine geopolitical tension will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, our fixed income strategy will remain defensive to shelter from the market volatilities in the near term.

Based on the table below, on a monthly basis, Asiapac Fund, Global Yakin Fund and Jati Fund managed to outperform the respective benchmark indices.

AsiaPac Fund Monthly Report (October 2023)

Investment Objective











Investment Objective

The Fund invests in MyETF Dow Jones U.S. Titans 50 ("MyETF-US50") which aims to provide investment results that closely correspond to the performance of the Dow Jones Islamic Market U.S. Titans 50 Index. The Fund is not a Shariah-compliant product.

Investment Strategy

MyETFDJ50 is managed by i-VCAP Management Sdn Bhd and it invests in 50 largest Shariah-compliant companies listed in the U.S. MyETFDJ50 is a passively managed fund.

Risks

The Fund is considered low risk given the exposure to only one underlying securities with no attempt to select stocks individually or to take defensive positions in declining markets. Risk is managed at the management level, where the asset allocation of the fund is to be reviewed on a regular basis and adjusted to be commensurate with the Investment Team's view on the relative attractiveness of each asset class.



Equity Market Review and Outlook

Market Review

For the month of October, the FBMKLCI Index closed higher by 1.3% MoM to 1,442.14 points, supported by the outperformance in banking sector. This has shrunk the YTD loss to -3.6% from -4.77% in a month earlier. The average daily trading value in the month fell 12.3% MoM but rose 15.6% YoY to RM2.0bil. Meanwhile, average daily trading volume in fell 8.9% MoM but rose 15.7% YoY to 3.1bil units.

Foreign investors turned net sellers in October after having previously been net buyers for three consecutive months. Foreign net sell flows were RM2.2bil in October, as compared to net buy flows of RM0.7bil in September. Local institutions recorded a net buy of RM2.3bil in Oct 23 (Sep 23: RM0.6mil net sell). Local retail investors recorded a net sell of RM114.9mil in Oct 23 (Sep 23: RM95.1mil net sell).

Meanwhile, global equity markets declined for the third consecutive month in October. This was dampened by middle-east conflict that impact to the energy sector, persistent inflation and mixed company earnings results. Dow Jones Industrial Index closed lower by 1.4% MoM and the broader S&P 500 index closed lower by 2.2% MoM. Eurozone shares also posted loss as the European economic showed contraction in some of its numbers. Bloomberg European 500 index closed -3.9% MoM. In Asia, the performances were also negative as concerns over the Chinese real estate sector and reports of new US restrictions on AI chip exports to China. MSCI Asia APEX 50 ex-Japan closed -3.2% MoM during the month.



Market Outlook & Strategy

Traditionally, FBMKLCI Index's performance tends to be negative in November, with average -0.5% for both MoM returns over the past 10 years and 45 years. We expect the market to be supportive by its attractive valuations at current levels of 1.29x as it is now below its 13-year historical average of P/B (1.90x) and 15.7x PER compared to the 13-year historical average of PER (17.2x).

Technically, the FBMKLCI Index has turned bullish with the index approached the 50-SMA. Backed by a the bullish MACD crossover, we expect the index will move towards the uptrend bias. Resistance level is seen at the psychological level of 1,500 and support level is at 1,400 level.

After series of interest rate hikes by the US Federal Reserve to fight against inflation in the 1H2023, the economy has proven to be more resilient than anticipated. We are more optimistic about the outlook for economic expansion this year. Locally, post OPR rate hike to 3.00% in May 2023, we expect BNM to maintain the OPR unchanged for the remaining of 2023. The OPR rate hike will be negatively impact to the local equity market for short term period. However, for longer term, we expect there will be recovery in the 2H2023 when the inflation started to inch lower. Historical analysis is suggesting that lower interest rates due to lower inflation will be positive for the equity market.

Fixed Income Review and Outlook

Market Review

Malaysia Government Securities ("MGS") yield continued to move higher, in line with the increasing global bond yields. Brend crude oil prices tumbled to USD87.41/barrel as at end-Oct'23 (end-Sep'23: USD95.31/barrel), due to the slower demand worries. Meanwhile, ringgit weakened further against the dollar to RM4.7635/USD (end-Sep'23: RM4.6950/USD), reflecting the heightened geopolitical tension in the Middle East.


On the local economic data, inflation was seen on its easing trend, lowering to +1.9% YoY in Sep'23 (Aug'23: +2.0% YoY). Food and Non-Alcoholic Beverages (FNAB) prices continued to moderate to +3.9% YoY (Aug'23: +4.1% YoY), in line with the easing of global food price inflation. Transport inflation remained muted, mainly supported by the Government subsidies on the RON95 and diesel fuel. Malaysia Exports and Imports marks the 7 consecutive months of decline, albeit at a slower pace by -13.7% YoY and -11.1% YoY respectively in Sep'23 (Aug'23: -18.7% YoY and -21.2% YoY respectively). All major Exports segments continued to decline in Sep'23, with Manufacturing by -11.8% YoY (Aug'23: -17.7% YoY), Agriculture by -23.1% YoY (Aug'23: -27.1% YoY) and Mining by -28.0% YoY (Aug'23: -23.3% YoY). Contraction in Imports was also seen in all segments, including Re-Exports (Sep'23: -17.9% YoY; Aug'23: -33.8% YoY), Intermediate Goods (Sep'23: -15.6% YoY; Aug'23: -22.5% YoY), Consumption Goods (Sep'23: -0.6% YoY; Aug'23: -5.5% YoY) and Capital Goods (Sep'23: -5.8% YoY; Aug'23: +5.3% YoY). In summary, trade surplus expanded to +MYR24.5b in Sep'23 (Aug'23: +MYR17.2b).


BNM's international reserve declined to USD108.9b as at mid-Oct'23 (mid-Sep'23: USD111.5b). The reserve is sufficient to finance 5.1 months of retained imports and is 1.0 times of short-term external debts.



US 10-year Treasury yield reached the 5.00% mark before easing slightly to 4.93% (end-Sep'23: 4.67%), reflecting the worries of substantial US debt issuances in the near future.

Market Outlook & Strategy

After a series of recent OPR hikes to pre-pandemic level, BNM is anticipated to keep its monetary policy unchanged in 2H2023, aiming to balance the economic growth and inflationary pressure in the country. The external risk factors such as Russia-Ukraine geopolitical tension will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, our fixed income strategy will remain defensive to shelter from the market volatilities in the near term.
