EXECUTIVE SUMMARY

The FBMKLCI Index continued its negative performance in the second month of the year to close at 1,482 points, lost 3.2% m-o-m. Other than the fear of Covid-19 outbreak, we had also witnessed local political scene turbulence in February which resulted in appointment of a new Prime Minister and a new cabinet line-up. The weaker-than-expected earnings results also dampened the sentiment on local equity market. Historically, FBMKLCI Index had posted an average gain of 0.4% in February over the past 10 years. The benchmark index had outperformed the FBM EMAS Index, which fell at a higher rate of -3.8% m-o-m and closed at 10,478.77 points.

Meanwhile, on the fixed income market, Malaysia Government Securities ("MGS") experienced strong rally again, mainly driven by the expectation of another 25bps Overnight Policy Rate ("OPR") cut in March as well as the worries of global economic slowdown arising from the Novel Coronavirus outbreak globally. In line, the Ringgit weakened to MYR4.2000/USD (Jan'20: MYR4.0965/USD) as the foreign investor flee the country. Weaker economic activities in China moved the Brent crude oil prices lower to USD50.52/barrel compared to a month earlier at USD58.16/barrel.

On the local economic front, Malaysia 4Q'19 GDP registered at +3.6% YoY (3Q'19: +4.4% YoY), the lowest point since 2009 global financial crisis. Inflation the other hand rose to +1.6% YoY (Dec'19: +1.0% YoY), mainly due to the higher domestic fuel prices.

Moving forward, we continue to remain cautious on the equity market. Given rising concerns over the outbreak of Covid-19 in Malaysia and globally, coupled with political instability, we expect the FBMKLCI to remain volatile. The effects will soon turn into weak corporate earnings in the next quarters. We will weighting on the defensive stocks amid uncertainty.

For fixed income, following the OPR cut by 50bps in 1Q2020 amid escalating US-China trade tension, BNM is expected to stay dovish monetary stance for the remaining of 2020, in line with the weaker economic prospect arising from the Novel Coronavirus outbreak in China. The external risk factors such as geopolitical tension in the Middle-East and fluctuation in crude oil prices will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, we will keep looking to buy on dips of corporate bonds if the opportunity arises.

Based on the performance table below, on monthly basis, most of the funds had outperformed the benchmarks, except for Income Fund.



Risks



Equity Market Review and Outlook

Market Review

The FBMKLCI Index continued its negative performance in the second month of the year to close at 1,482 points, lost 3.2% m-o-m. Other than the fear of Covid-19 outbreak, we had also witnessed local political scene turbulence in February which resulted in appointment of a new Prime Minister and a new cabinet line-up. The weaker-thanexpected earnings results also dampened the sentiment on local equity market. Historically, FBMKLCI Index had posted an average gain of 0.4% in February over the past 10 years. The benchmark index had outperformed the FBM EMAS Index, which fell at a higher rate of -3.8% m-o-m and closed at 10,478.77 points.

The average daily value traded on the Malaysian equity market improved 25% m-o-m and 16% y-o-y to RM2.6 billion during the month. The monthly increase in trading value could be partly due to higher trading participation by foreign investors due to the country's political upheaval and sell-off in global markets during the last week of Feb due to concerns over the Covid-19's impact on the global economy. Foreign investors sold a total of RM 2 billion of Malaysian equities, the highest outflow in six month. This was a negative development as foreign net outflow appeared to be subsiding in January. Foreign investors accounted for 26% if the average daily trading participation.

The global equity performances were also affected by the Covid-19 fears which sent the stocks into correction territory in February. In the US, Dow Jones and S&P 500 lost -10.1% and -8.4% to close at 25,409.36 points and 2,954.22 points respectively. Meanwhile, Bloomberg European 500 index closed lower by -8.6% on monthly basis and MSCI Asia APEX 50 ex-Japan closed lower by -1.5% m-o-m. Brent crude oil price closed at USD50.52 per barrel, lower by 13.1% m-o-m.

Market Outlook & Strategy

Technically, the FBMKLCI had breached the psychological support of 1,500 during the month to 1,482.64 points, its lowest level in eight years. The outbreak continued to dampen the global sentiment financially. Support was seen at Fibonacci target of 1,430 and 1,380 levels and near-term upside capped at 1,500-1,530. Based on historical data, the FBMKLCI's performance tends to be mixed in March, having registered an average monthly gain of 1.6% over the past 10 years.

Moving forward, we continue to remain cautious on the equity market. Given rising concerns over the outbreak of Covid-19 in Malaysia and globally, coupled with political instability, we expect the FBMKLCI to remain volatile. The effects will soon turn into weak corporate earnings in the next quarters. We will weighting on the defensive stocks amid uncertainty.

Fixed Income Review and Outlook

Market Review


Malaysia Government Securities ("MGS") experienced strong rally again, mainly driven by the expectation of another 25bps Overnight Policy Rate ("OPR") cut in March as well as the worries of global economic slowdown arising from the Novel Coronavirus outbreak globally. In line, the Ringgit weakened to MYR4.2000/USD (Jan'20: MYR4.0965/USD) as the foreign investor flee the country. Weaker economic activities in China moved the Brent crude oil prices lower to USD50.52/barrel compared to a month earlier at USD58.16/barrel.

On the local economic front, Malaysia 4Q'19 GDP registered at +3.6% YoY (3Q'19: +4.4% YoY), the lowest point since 2009 global financial crisis. Inflation the other hand rose to +1.6% YoY (Dec'19: +1.0% YoY), mainly due to the higher domestic fuel prices (RON95: MYR2.08 in Jan'20 vs MYR2.00 in Jan'19). Malaysia's exports and imports dropped by -1.5% YoY and -2.4% YoY respectively (Dec'19: +2.7% YoY and +1.0% YoY respectively) due to the Lunar New Year and emergence of Covid-19 outbreak. All in all, the trade balance was last seen at +MYR12.0 billion (Dec'19: +MYR12.5 billion).

External reserve fell to USD103.4 billion as at end-Feb'20 (end-Jan'20: USD104.2 billion) on the back of portfolio capital outflows arising from market risk-off sentiment amid Novel Coronavirus outbreak and local political uncertainties. The reserve is sufficient to cover 7.4 months of retained imports and 1.1x short term external debt and is above the IMF's adequate reserve level of USD90.2 billion.

The 10-year US Treasury ("UST") continued to rally, driving the yield lower to 1.15% (Jan'20: 1.51%) as the investors seeking safe-haven assets on the back of worsening global economic outlook, on-going US-China trade war, geopolitical tension in Middle-East region, and the increasing risk of Novel Coronavirus outbreak globally

Market Outlook & Strategy

Following the OPR cut by 50bps in 1Q2020 amid escalating US-China trade tension, BNM is expected to stay dovish monetary stance for the remaining of 2020, in line with the weaker economic prospect arising from the Novel Coronavirus outbreak in China. The external risk factors such as geopolitical tension in the Middle-East and fluctuation in crude oil prices will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, we will keep looking to buy on dips of corporate bonds if the opportunity arises.
