EXECUTIVE SUMMARY

The FBMKLCI Index rallied initially in the month of March before closed 1.3% lower MoM to 1,587.36 points toward the month end. The monthly loss was mainly contributed to the profit-taking activities by the investors on the concern over the potential inflationary impact of trade sanction on Russia.

Malaysia Government Securities (“MGS”) yields surged across the curve, reflecting that the major world economies have started to hike interest rates in combating the increasing inflationary pressure globally. Following the intensified Russian-Ukraine tension, Brent crude oil prices continued to surge higher to USD139.13/barrel before easing back to USD107.91/barrel as at end-Mar’22 (end-Feb’22: USD100.99/barrel). Meanwhile, Ringgit weakened slightly to MYR4.204/USD as compared to MYR4.199/USD in a month earlier.

On the local economic data, the inflation eased further to +2.2% YoY in Feb’22 (Jan’22 +2.3% YoY), mainly attributable to the diminishing base effect of transport cost (Feb’22: +3.9% YoY; Jan’22: +6.0% YoY). Despite of the rising global crude oil prices, the local subsidy of RON95 fuel and diesel fuel kept inflation in check at the moment.

For equity market, in short term, we expect the market will take advantage on the rising commodity prices, borders reopening, and better corporate earnings. For the longer run, we believe the local equity market will improve supported by better domestic activities locally and foreign support. However, we are still cautious on the increasing market volatility and external uncertainties.

For fixed income, BNM is anticipated to tune monetary stance to slight hawkish in 2022 when the COVID-19 pandemic is nearing to the end. The external risk factors such as Russia-Ukraine tension and the fluctuation in crude oil prices will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, we will keep looking to buy on dips of corporate bonds if the opportunity arises.

Based on table below, on monthly basis, most of the funds managed to outperformed the respective benchmarks, except for Jati Fund.

Policyholders are encouraged to focus into regular premium given the current risk and volatile period of the economic and market condition. Risk adverse investors should focus into income fund due to its less volatile as compared to equity related funds.

Investment Objective















Equity Market Review and Outlook


Market Review

The FBMKLCI Index rallied initially in the month of March before closed 1.3% lower MoM to 1,587.36 points toward the month end. The monthly loss was mainly contributed to the profit-taking activities by the investors on the concern over the potential inflationary impact of trade sanction on Russia. The average daily trading volumes fell 9% MoM to 3.2bil units in March, while average daily trading value improved 6% MoM to MYR3.04bil.

During the month, foreign investors were the largest net buyers of RM3.3bil of local equities (MYR2.8bil in February '22). This lowered the cumulative net foreign outflows since 2010 to MYR28.4bil. Local institutional investors continued as net sellers of MYR3.6bil worth of equities (MYR2.8bil net sell in February '22). Meanwhile, local retailers' net buying rose to MYR321mil (from MYR98mil in February '22).

Globally, month of March 2022 saw the reversion of the market where most of the indices rebounded on monthly basis. It was supported by the commodity and energy-related stocks which recorded their strong performance in six months. In the US, Dow Jones Industrial index strengthened by 2.3% MoM and the broader S&P 500 index closed higher by 3.6% MoM. Meanwhile in Europe, the performances of the indices were mixed but with positive biased. Amidst no sign of resolution in the Russia-Ukraine war, Bloomberg European 500 index managed to close 0.7% MoM higher. Meanwhile in Asia, the performance was mixed with negative bias. The MSCI Asia APEX 50 ex-Japan closed 3.0% MoM lower during the month.

Market Outlook & Strategy

Traditionally, FBMKLCI index's performance tends to be positive in April, with an average monthly return of 0.7%/2.1% over the past 10 years/44 years. We expect the market to be supportive by its attractive valuations at current levels of 1.61x as it is now below its 25-year historical average of P/B (1.82x) and 15.8x PER compared to the 22-year historical average of PER (17.0x). As at 2nd April 2022, 79% of Malaysia's population has taken the second dose of Covid-19 vaccine, meanwhile 48.5% has taken the booster. This has slightly lifted the market sentiment with more economic and social activities leniency were allowed by the government, especially with the international border reopening starting 1st April 22.

Technically, the FBMKLCI Index weakened in March with lower trading volume recorded. Since 2H21, the local index has been volatile to be trading within 1,480-1,615 range. We expect the index to stay range-bound in April with the upside capped by the strong resistance at 1,618-1,625. The index is likely to find the 200-week EMA and the 1,600 psychological resistance tough to crack. Support is seen at the 1,555 levels, followed by 1,520.

For short term, we expect the market will take advantage on the rising commodity prices, borders reopening, and better corporate earnings. For the longer run, we believe the local equity market will improve supported by better domestic activities locally and foreign support. However, we are still cautious on the increasing market volatility and external uncertainties.

Fixed Income Review and Outlook

Market Review

Malaysia Government Securities (“MGS”) yields surged across the curve, reflecting that the major world economies have started to hike interest rates in combating the increasing inflationary pressure globally. Following the intensified Russian-Ukraine tension, Brent crude oil prices continued to surge higher to USD139.13/barrel before easing back to USD107.91/barrel as at end-Mar’22 (end-Feb’22: USD100.99/barrel). Meanwhile, Ringgit weakened slightly to MYR4.204/USD as compared to MYR4.199/USD in a month earlier.

On the local economic data, the inflation eased further to +2.2% YoY in Feb’22 (Jan’22 +2.3% YoY), mainly attributable to the diminishing base effect of transport cost (Feb’22: +3.9% YoY; Jan’22: +6.0% YoY). Despite of the rising global crude oil prices, the local subsidy of RON95 fuel and diesel fuel kept inflation in check at the moment. Food & Non-Alcoholic Beverages (“FNAB”) on the other hand continued to creep higher to +3.7% YoY (Jan’22 +3.6% YoY) on the back of the adverse weather condition and high input costs.


External trade growth eased slightly to +16.8% YoY in Feb’22 (Jan’22: +23.9% YoY). The easing in growth was seen in all three major sectors, namely manufacturing exports, agriculture exports and mining exports. Manufacturing exports were supported by the steady growth in E&E products at +25.8% YoY (Jan’22: +22.4% YoY) while Rubber Products dropped for six continuous months to -59.3% YoY (Jan’22: -53.4% YoY). Imports growth also eased with Intermediate Goods at +21.8% YoY (Jan’22: +28.3% YoY), Consumption Goods at +18.3% YoY (Jan’22: +32.4% YoY) and Capital Goods at +4.4% YoY (Jan’22: +36.4% YoY). All in all, the trade surplus came in at +MYR19.8b as compared to +MYR18.4b in a month earlier.

Malaysia external reserve declined slightly to USD115.6b as at end-Mar’22 (end-Feb’22: USD115.8b). The reserve is sufficient to cover 6.1 months of retained imports and 1.2 times short-term external debt.



The 10-year US Treasury yield spiked and tested 2.50% before easing back to 2.34% as at end-Mar’22 (end-Feb’22: 1.83%) given the rising inflationary pressure. In the recent FOMC meeting, the US Fed hiked the key rate by 25bps to 0.25%-0.50% range, and stated that further increase in the target rate would be appropriate.

Market Outlook & Strategy

BNM is anticipated to tune monetary stance to slight hawkish in 2022 when the COVID-19 pandemic is nearing to the end. The external risk factors such as Russia-Ukraine tension and the fluctuation in crude oil prices will continue to weigh on the local market, but we believe corporate bond space still provides attractive yields. As such, we will keep looking to buy on dips of corporate bonds if the opportunity arises.
